Project Status Report Measure G & J –Eric Mittlestead	 A) Bakersfield College/Delano Center, B) Cerro Coso Community College, C) Porterville College, D) District Office Mr. Mittlestead presented a summary Power Point report Measure G SRID, 2nd quarter ending December 31, 2018 that is attached hereto and incorporated herein. District SRID Spending Summary included the original Measure G budget of \$180,000,000. Interest and other revenues are \$25,041,505. Total SRID Funds are \$205,041,505. Total Funds spent to date are \$171,005,374. Total Funds available for use \$34,086,131. A bar graph showed SRID Expenditures by College, including District Office of \$25,590,299, Porterville College of \$27,670,131, Cerro Coso Community College of \$40,704,853, and Bakersfield College of \$77,040,091, totaling \$171,005,374. The next slide shows a total of \$34,036,131, of unspent funds.

	In addition, Eric reported on the District Measure J spending summary for 2nd quarter ending December 31, 2018. Spending summary included the original Measure J budget of \$502,821,000. Interest and other revenues are \$809,487. Total Measure J funds are \$503,630,44, Total Measure J funds spent to date are \$21,384,284. A bar graph showed expenditures by College including District Office of \$4,048,955, Porterville College \$346,703, Cerro Coso Community College \$10,530,425, and Bakersfield College \$6,458,200, totaling \$21,384,284. Total of Measure J unspent funds are \$482,246,159.
