Notice is hereby given that the Kern Community College District (OWNER) will receive sealed bids for the Bakersfield College Delano Center Monument Sign/Sidewalk and Landscape Phase II project.

All bids must be received at the Kern Community College District Office, 2100 Chester Avenue, (entrance on east side) Facilities Department, 2nd Floor, Bakersfield, CA 93301 by 3:00 p.m. on Thursday, November 06, 2025, and will be publicly opened at or after that time.

A Mandatory Job Walk will be held on Thursday, October 23, 2025, at 1:00 p.m. Meet at Bakersfield College Delano Center 1450 Timmons Ave, Delano, CA 93215. No bid will be considered unless it is made on the bid form furnished by the District.

ALL PROJECTS OVER \$1,000 ARE SUBJECT TO PREVAILING WAGE MONITORING AND ENFORCEMENT BY THE LABOR COMMISSIONER.

It shall be mandatory upon the contractor to whom the contract is awarded (CONTRACTOR), and upon any SUBCONTRACTOR, to pay not less than the specified rates to all workers employed by them in the execution of the contract.

15. A Payment Bond for contracts over \$25,000 and a Performance Bond for all contracts will be required prior to commencement of work. These bonds shall be in the amounts and form called for in the Contract Documents.

Pursuant to the provisions of Public Contract Code Section 22300, CONTRACTOR may substitute certain securities for any funds withheld by OWNER to ensure CONTRACTOR's performance under the contract. Upon satisfactory completion of the contract, the securities shall be returned to CONTRACTOR.
