## Answers to bidder questions:

**Q1.** Will you accept Non-OEM forklift controls, meaning a forklift control system that replicates and functions the same way as OEM?

Answer: Yes.

**Q2.** Are you requiring a 1 year software subscription to be included in the price?

**Answer:** No. If the subscription offers support and data analytics then it is recommended. The bid schedule has a line item of Annual Software/Subscription, if applicable.

**Q3.** The RFP specifications show a different quantity than the Bid Schedule. The request was for different quantities of each, however in the bid price list, the quantities listed are for "1".

**Answer:** This project has a budget of \$400,000 for 10 total units, 6 stand up and 4 sitdown trainers. The bid schedule is for <u>each</u> type of forklift simulators. You may also attach a quote with the bid schedule.
