Answers to bidder questions:

Q1. Given the scope that you are looking for, we don't believe that a high-quality project will be completed in the given timeframe which is by August 30, 2024. While we are very interested in this project and believe that we have the capabilities to best complete this, with the current proposed timeline we see that it is unlikely for a firm to complete a high-standard project for you.

We wanted to inquire if you would be able to extend the duration of the project. If it's possible to change the timeline, we will be bidding and will submit a full proposal for your review.

Answer: The timeline is set by State guidelines, and we are unable to extend the duration of the project.

Q2. Additionally, we would like to add that upon reviewing the previous regional plan that was conducted, we detected multiple errors with the data collected. With that under consideration, we would anticipate the new report would require a significant rewrite.



Answer: The State deadline for the amended Regional Plan 1 is April 30, 2024. Any updates to this plan would need to be completed by that deadline.

All other specifications remain unchanged.
