Bakersfield College Enrollment Update

Thanks to the ongoing efforts of all employees at Bakersfield College, as of the September 8 report prepared by Institutional Research, Bakersfield College's headcount is up 1.5% over last year to 17,589, and our FTES is up 1.1% over last fall to 6,079.5.

We are meeting our enrollment challenges by collaborating, by working smart, making decisions based on data to meet student need. In the last few weeks, a team representing instruction, human resources, student services, and marketing banded together to add an additional 20 courses to our fall lineup. The courses offered were selected based upon student waitlists at peak hours of the day; courses were added at four different instructional sites. the college began marketing courses through social media, websites, and news media. Our message to students is clear: we want to help you get the classes you need.

Many other efforts are helping us meet our students' needs, including a series of It's Possible! events coordinated by our new outreach department. Each event was directly focused on former students, or to students who had completed an application but never took courses. During the It's Possible! events, students could take their placement tests, attend orientation, meet with a counselor, develop and educational plan, and register for classes --- all in one day!

Construction on Campus

Since last Spring, our much needed water and gas line replacement project has kept the physical campus in a constant state of construction turmoil. Major kudos to the skilled Maintenance and Operations team, security and groundskeepers for keeping students and employees informed and safe, and minimizing disruption as the work areas evolve on a weekly basis. Since the beginning of the project, we have sent 20 emails, posted information on social media, created a construction information website, sent "Staying Safe During Construction" tips to students and staff, and posted reminders all over campus to stay safe.

Even through inevitable setbacks, the College has been able to avoid serious accidents on campus. All staff and students are encouraged to report any dangerous situations to M&O or Public Safety, and our team has worked to correct the issues immediately. The project is expected to be completed in February, 2015.



LEARN@BC Title IX and Clery Act Symposium

Federal law requires colleges and universities to understand how Title IX regulations and the Clery Act affect every employee across campus and create a responsibility to report crimes and other conduct violations. Through the *Title IX and Clery Act Symposium*, employees across the Kern Community College District will receive in-depth education on the federal laws, and walk away with the information they need to know when, why and how to report violations.

New bipartisan legislation will increase penalties for violations. Schools that do not comply with specific requirements of the federal law can be fined up to 1% of their operating budget.
