

Here is a COVID advisory update.

All Kern County Residents 65 and Older Eligible for Vaccine

Right now, <u>all Kern County residents 65 and older are eligible for the COVID-19 vaccine</u>. Kern County is currently in the first part of Phase 1B, and the next population to get access to the virus will be at-risk individuals working in education, child care, emergency services, and food and agriculture. Virtually all health care workers in the county are currently eligible for the vaccine. Check out the image below to see when you might be eligible:



Kern County Public Health has also created <u>an interactive vaccine map</u> with all of the locations in the county that are distributing the virus. Visit the page and click on one of the orange dots for information about the site, or click on the "Find Vaccinations Near You" button and enter your address to find sites within a 5 or 10 minute drive.

Local Education Roundup: Rosedale Union Bringing Back TK-2 for In-Person Instruction, KHSD Sends Out Vaccine Survey for Employees, BCSD Outlines Plans for Learning Loss

As Governor Newsom begins rolling out the state's Safe Schools For All program to encourage in-person instruction starting with our youngest learners (more details on that initiative below), some students in the Rosedale Union School District returned to their physical campuses on Tuesday, Jan. 19. Students in transitional kindergarten through second grade are returning to in-person learning, as well as special education students in other grades.

Third grade through sixth grade will be returning to campus on Feb. 1, and middle school students will be the last group to come back starting Feb. 9. Parents and guardians can choose to opt out of in-person learning and continue with virtual instruction, but if they choose to commit, they must leave their students in in-person instruction until at least the end of the quarter.

As the Kern High School District begins considering its reopening plans, they've sent out an anonymous survey to employees throughout the district asking if they would be interested in opting in to a vaccine. The district is looking to gauge response for interest in the vaccine, and employees who opt in will have a no-cost option for vaccination.

Mark Luque, the Deputy Superintendent for the Bakersfield City School District, <u>presented an early outline for a plan to proactively mitigate the ongoing learning loss that has occurred due to the pandemic</u>. The plan, which will be presented more fully at an upcoming BCSD board meeting, includes a summer academy and supplemental learning through afterschool and weekend academies in the next academic year.

California Launches Safe Schools for All Hub



Governor Newsom has launched the Safe Schools for All initiative to provide support for schools looking to open up for in-person instruction, starting with their most vulnerable students. For our youngest children, students with disabilities, and students without access to the resources to sustain virtual instruction, the Governor's Office is arguing that the benefits and resources that come with in-person learning outweigh the potential dangers of the virus, which can be mitigated with masks and social distancing.

Under the current Safe Schools for All guidelines, if a district is in a county with 25 new cases per 100,000 or less, they are eligible for the program, which provides a base amount \$450 per student and potentially more based on the number of high needs students in the district, as determined by a Local Control funding formula. For more information, EdSource published a helpful guide to the Safe Schools For All Initiative.

On Thursday, January 14, Governor Newsom announced the <u>Safe Schools For All hub</u>, which contains information and resources for schools looking to reopen, as well as portals for faculty, staff, and parents to request technical assistance or report their concerns. The program also includes \$4.6 billion in funding for districts to expand

summer school offerings and prioritize low-income students, foster youth and other vulnerable populations.

LA County reaches 1 million confirmed cases

On Saturday, January 16, <u>Los Angeles County announced that it was the first in the US to record more than 1 million confirmed cases</u> of coronavirus since the start of the pandemic last year. LA County also announced its first confirmed case of the B.1.1.7 variant that was first discovered in the UK. An estimate based on scientific modeling suggests that <u>1</u> in every 3 LA County residents has been exposed to the virus.

Federal Vaccine Reserve Runs Out

Outgoing Health and Human Services secretary Alex Azar previously stated that the federal government would be releasing vaccine doses to states from its "physical" reserve. However, The Washington Post reported on Friday, January 15 that the vaccine reserve had already been exhausted and no physical stockpile actually exists. Health officials who were expecting to increase their supplies of the vaccine are now left high-and-dry, as many hadn't been notified about the lack of reserve stock until last week.

However, states are still receiving vaccine shipments, and individuals who need their second dose of the vaccine will be prioritized over first shots. NBC News covered the blame game between state and federal officials, with state governors and other politicians claiming they were misled about the vaccine reserves while federal officials criticized states for micro-managing the existing supply of the vaccine.

One-shot vaccines from AstraZeneca, Johnson and Johnson Show Promise in Early Clinical Trials

While the Phzer and Moderna vaccines continue to spread across the country, new vaccines are being tested by AstraZeneca and Johnson and Johnson. Time Magazine wrote a detailed feature about the Johnson and Johnson vaccine on Thursday, January 14, noting that 90 percent of clinical participants created antibodies within 29 days after receiving the shot. The Johnson and Johnson vaccine only requires one treatment to administer, compared to the Phzer, Moderna and AstraZeneca vaccines which require two doses. Meanwhile, the vaccine developed by Oxford University and AstraZeneca vaccine received emergency approval in the UK in late December, and Pakistan approved emergency use of the vaccine on Saturday, January 16.

In an interview with Chuck Todd on Meet the Press on Sunday, January 17 (Sunday, January 17), Dr. Fauci noted that the two new vaccines are "weeks away, not months away" from emergency FDA approval in the United States.

CDC: COVID Variant Could Become Dominant Form of Virus by March

<u>In a press conference on Friday, January 15</u>, the Centers for Disease Control and Prevention acknowledged the presence of the B.1.1.7 variant in the United States, stating that individuals will need to be more vigilant in adhering to social distancing protocol as the variant discovered in the UK in December becomes the dominant strain in the US by March.

In addition to the B.1.1.7 variant, a new variant called P.1 was discovered in Brazil, and researchers are concerned that this variant could bypass the human immune response. Science Magazine reported on the two new variants and others on Friday, January 15, concluding that more research is needed to test if the variants are immune-resistant.

Blueprint For a Safer Economy Dashboard

The State of California's Blueprint For a Safer Economy dashboard has been modified to fit the new guidelines announced in August. A table with the comparison of test positivity rates from several counties on the monitoring list is below.
