### Senate Passes Third Stimulus Bill; Biden Predicts Vaccines For Every Adult by May

On Saturday, March 6, <u>the US Senate approved a \$1.9 trillion COVID-19 relief package</u>. The amended bill, which includes \$170 billion for K-12 schools and higher education, will go back to the House of Representatives for approval before it can be signed into law by President Biden.

Last week, when President Biden announced that pharmaceutical giants Merck and Johnson and Johnson would be working together to produce vaccines, <u>he made an</u> <u>optimistic projection that vaccines would be available for all Americans by the end of</u> <u>May</u>, which is a drastic acceleration of his initial projection when he took office in January.

California Reaches 10 Million Vaccines Administered

On March 5, Governor Newsom <u>announced via Twitter</u> that the state had passed 10 million vaccinated. If California were its own country, it would be 7th in the world in the number of vaccinations that have been administered across the state.

### Newsom Speaks to KGET About Plan to Vaccinate Vulnerable Zip Codes



On Thursday, March 4, <u>KGET published an interview with Governor Newsom</u> talking about his plan to provide more vaccine allotments to vulnerable areas and the implications that might have on Kern County residents' access to the vaccine. Residents in 400 zip codes will receive a personal code to receive priority access to the vaccine via the <u>the MyTurn website</u>. A full list of Kern County area codes that will be part of this initiative is listed on the KGET website and includes most of Bakersfield, Delano, Arvin, Wasco, Lamont and more.

### Vaccine Tracker

The Centers for Disease Control and Prevention has <u>a vaccination dashboard</u> that tracks the number of COVID-19 vaccines administered and delivered across the United States. The California Department of Public Health has <u>a dashboard tracking vaccinations in the</u> <u>state overall</u> and by county. However, neither the CDC or CDPH dashboards provide information about the number of vaccine doses delivered by county.

## Johns Hopkins Dashboard

As of 10 a.m. on March 7, the <u>Johns Hopkins University Dashboard</u> shows more than 116 million confirmed cases of COVID-19 worldwide since the start of the pandemic. Additionally, the United States surpassed 500,000 COVID-19 deaths last week. Here is the table that captures the difference in the numbers since February 28.
