Enrollment Update

Based on the May 27 enrollment report prepared by the Institutional Research Office, BC's summer enrollment is up3.6% compared to summer 2019. This indicates that the recent introduction of our normal outreach activities, albeit in a virtual environment, is showing that enrollments are on the upswing. I am anticipating the same to happen with Fall 2020 enrollments as well.

Commencement Update

We have over 3,000 students graduating this year with an associate's degree. In addition to a future opportunity to participate in May 2021's in-person commencement ceremony, BC will celebrate this year's graduates with a photo roll recognition of the class of 2020. California Reopening

On March 26, Governor Newsom announced counties with approved attestations, including Kern, can begin moving into the early part of stage 3 of the Resilience Roadmap. Newsom also made clear that the decision to move further into stage 3 will be a local decision, but stage 4 movement is not yet permitted. Declaring "localism is determinative," he announced that counties should follow the guidelines set forth at the state level, but must work with their public health leaders to determine pace of reopening. Kern has since announced approval for stage 3 industries to reopen.

During his Friday, May 29 update, Newsom reminded us that as the state increases testing significantly, positive case numbers will also rise. According to covid19.ca.gov, the positivity rate has remained relatively stable at around 4.5% over the past 14 days, while Kern's positivity rate over the past 14 days is higher at 5.5%.

As a reminder, here is BC's framework for essential activities to return to campus.

Summer 2020:

Summer 2020 at BC looks very different than in previous years with significantly fewer sections on campus to ensure a minimal, essential footprint for the safety of our students, faculty, and staff.

Fall 2020 on-campus activity must be significantly reduced for BC's public health and safety protocols to be realistic and effective. In fall, we are currently scheduled with only 568 courses or 26% of courses being offered face-to face.
